- **INSURANCE** : If you don't have insurance our policy will cover any one without an ABN for Public Liability Only ( noting that there is a \$1500 excess payable by yourself if there is a claim)  
**Please note that there is no cover for Products under our insurance.**  
For your interest I have included ***My Market Insurance details*** that may be of interest to you. Their cover is very reasonable and covers public liability and product insurance – go to for more information [mymarketinsurance.com.au](http://mymarketinsurance.com.au)
- **CANCELLATION**: If you cancel your site, two weeks prior notice is required. A \$10 admin fee will be charged on cancellations under two weeks. The full market lane fee will be forfeited if cancellation is made within one week.
- **SITE**: The Southern Yorke Peninsula Agricultural Society Inc reserves the right to a final decision on all site applications.
- **RESPONSIBILITY**: Southern Yorke Peninsula Agricultural Society Inc will not be responsible for any accident or incident that may be caused through or by any merchandise or food of site holders. It shall be a condition of approval that each site holder shall hold the society blameless and indemnified against legal proceedings from such incidents of accidents. It is agreed that the Southern Yorke Peninsula Agricultural Society Inc will not, under any circumstances, be held responsible for any loss or damage to the stock in trade, equipment, stalls, etc. or any part thereof belonging to an exhibitor.
- **SET UP & PACK UP**: Set up of sites **MUST BE COMPLETED** prior to show opening the gate to the public at 8:30am Wednesday 8<sup>th</sup> October 2025. Displays, stalls and fixtures, **MUST NOT BE DISMANTLED** nor goods and/or materials **REMOVED** and the exhibit **MUST REMAIN OPEN** prior to the end of the SYP Show.
- **UNDER NO CIRCUMSTANCES** shall you remove or dismantle your stall prior to the designated time of 5:00pm (unless prior written arrangements with Southern Yorke Peninsula Agricultural Society Inc). Any vehicle is banned from moving whilst public are on the showgrounds.
- Failure to abide by these conditions could see your future trade site applications to not be considered by the SYPASI committee.
